- CALL TO ORDER: The meeting was called to order by Chairperson, Kathie Steele at 6:30 p.m.
- II. APPROVE/AMEND AGENDA: Jeri Pietzold moved to approve the meeting agenda as amended to add another item to New Business, Tree Pruning. The motion was seconded and unanimously approved.
- III. APPROVAL OF PREVIOUS MINUTES: Kathie Steele moved to approve the minutes for the August 27, 2015 meetings. The motion was seconded and approved.

The Board will consider installing more signage to make it obvious that Murray Park is private property.
